## BACKGROUND

This action is part of the Council of Europe Action Plan for Ukraine 2018 -2021 and is implemented within the project “Further support for the execution by Ukraine of judgments in respect of Art.6 of the ECHR.

In October 2020, PACE expert produced a Monitoring and Evaluation Report on the functionality of the Sub-Committee on the execution of judgments of the European Court of Human Rights and Alternative Dispute Resolution of the Committee on Legal Policy of the Verkhovna Rada of Ukraine. The aim of the Report is to assess the functionality of the mechanism and assist the Sub-Committee in developing a working framework, with concrete guidelines and recommendations.

The research was carried out in line with PACE Resolution 1823 (2011) “National parliaments: guarantors of human rights in Europe” and PACE Handbook for parliamentarians “National parliaments as guarantors of human rights in Europe” and covers the period from June 2017 to June 2020.

The online event proposes to discuss the content and recommendations with Members of the VRU, responsible for human rights domain.
